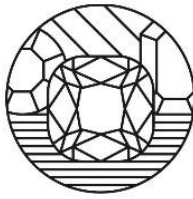

A SOLITAIRE DIAMOND RING

Cast component and hand assembled in 18 carat yellow gold and platinum tested using XRF metal analysis
 Stamped: 750

The ring features a GIA certified oval brilliant cut diamond in a platinum four pillar V styled setting with collet support and joined to a yellow gold reverse tapered band with a half round profile, a comfort curve finish and under-rail support. The band measures 2.43-1.85mm in width, 1.93mm in thickness and the setting measures 5.37 x 3.62 x 4.76mm.

Valuation summary

Value Definitions

The Valuation is valid for one year effective from the date completed.

Estimated Cash Realization Value - Our opinion of the most likely value of the article for cash realization, usually between 10-15% of the article's new retail value. Condition of the article is factored into this value.

Limitations

Unless otherwise stated, all gemstone identifications, estimated carat weights, measurements and grades are assessed in their settings using industry standard methodology.

Actual weights and/or grades apply to diamonds and coloured gemstones that have been presented with a certificate or with details from the supplier. Any certificates or documentation withheld from the valuer at the time of the valuation may render this valuation invalid.

All precious metals are tested by acid and/or electronically and will this be stated on your valuation. The overall condition of each item has been checked and considered satisfactory unless otherwise stated.

It is common practice for gemstones to be subjected to acceptable treatment(s) to improve their colour and/or durability. Detection of certain treatments require advanced Gemmological testing equipment which is beyond the scope of this valuation.

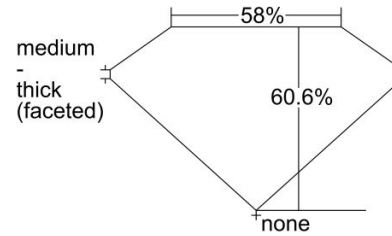
